Space Is Limited: Register Early!

Registrations are accepted on a first-come, first-served basis. Although, training is conducted online, there are limitations on the number of students we can grant online access to. The number of students may also be limited by the instructor to ensure class sizes are manageable.

Invoicing and Payments

Once you fill out the online registration form you will be sent an automated confirmation email from <u>Training@scanco.com</u> confirming receipt of your form submission.

A short time after, a second email will then be sent from a Scanco Training Associate with an invoice attached for the class(es) and registrants you have purchased.

Once you receive the invoice you can access the Scanco <u>Online Payment Portal</u> to make your payment.

We accept AMEX, VISA and, MASTER CARD. **PERSONAL OR COMPANY CHECKS ARE NOT ACCEPTED.** Your reservation is not confirmed until your tuition payment is received and processed.

Once processed you will receive confirmation via email that we have received your payment and will follow up with any training materials and/or instructions for accessing the online training class.

Refund Policy

For students who wish to cancel their enrollment, notice must be provided to Scanco Software, LLC one week (7 calendar days) prior to the class start date to avoid loss of tuition. Students canceling or rescheduling less than 7 calendar days prior to the class start date will forfeit their tuition. Substitution of a registrant is allowed at no additional charge.
