For All Current Versions of Scanco Developed Software Products

The Software is copyrighted and all rights reserved by Scanco and is published and distributed exclusively by Scanco. The distribution and sale of the Software and its output is intended for the use of the User only and for use only in connection with the single computer on which it is originally installed. User is licensed to read from the Software's medium into memory of the computer for the purpose of executing the program and/or to make a copy the program for the purpose of archival backup only, provided such copy is made solely in support of User's operation of the program on a single computer.

User may not modify or merge any portion of the Software or its output into another computer program or device without the prior written consent of Scanco.
